SCHEETZ STATES THAT HACHEL WENT TO THE "PURE" NIGHT CLUB ON THE NIGHT OF AUGUST 28TH AND RETURNED TO THE ROOM AT ABOUT 0300 HOURS ON THE 29TH. SCHEETZ STATES HACHEL APPEARED TO BE FINE WHEN HE LEFT TO CONDUCT BUSINESS AT ABOUT 2000 HOURS. SCHEETZ STATES HE RETURNED HOME AND FOUND HACHEL LAYING FACE DOWN ON THE BED, NOT BREATHING AND COLD TO THE TOUCH, AT WHICH TIME HE CALLED 9-1-1. SCHEETZ INFORMED POLICE THAT HACHEL USED ILLEGAL NARCOTICS AND OFFICERS FOUND A WHITE POWERY SUBSTANCE NEAR HACHEL'S PURSE. COR. INV. HERRIEOND PRONOUNCED AT 2200 HOURS AND IS RULING UNDETERMINED PENDING AUTOPSY. HITES FUNERAL HOME TRANSPORTED HACHEL TO THE CLARK COUNTY CORONER'S OFFICE.
