15 said DEBBIE FLORES to prevent her from having or using it and defendant throwing it, and
16 when the said DEBBIE FLORES went to retrieve it, defendant pulling her hair and kicking
17 her.

18 All of which is contrary to the form, force and effect of Statutes in such cases made
19 and provided and against the peace and dignity of the State of Nevada. Said Complainant
20 makes this declaration subject to the penalty of perjury.

DETAILS:

On October 22, 2010, I, Officer K. Pearson, P#14073, and Officer C. Forson, P#14082, responded to Vegas and Torrey Pines where Officer J. Rowberry, P#13894, was out with two vehicles stopped in the road. The first vehicle was Maryland plate 73547CD, which had bumped into the front vehicle. It was Nevada plate BLU21. Upon arrival, I made contact with Debbie Flores, the driver of the Maryland plate. Flores stated she is currently dating Jason Griffith and has been dating for one year. She is also pregnant with his child. Griffith is the driver of the Nevada plate BLU21. Flores stated that she was at [REDACTED] visiting Agnes Roux, Griffith's ex-girlfriend. Griffith then arrived at Roux's residence, which Flores was in her vehicle. Flores stated that Griffith approached her, opened the car door, took her Iphone, and elbowed her in the left chin. Flores had no visible facial injuries. Flores stated that Griffith then left on foot, Iphone in hand, and then returned to his vehicle, which was parked in front of Flores' vehicle.

Griffith then left. Flores followed and Roux did as well in her vehicle. Griffith finally stopped at [REDACTED]. All parties exited their vehicles and Flores and Griffith then began verbally arguing about the Iphone. Flores stated that Griffith then threw her Iphone approximately 100 feet. Flores stated that before Griffith threw the phone, Griffith stated that he was not going to jail. Flores also stated that Griffith stated the same thing as he took her phone the first time at [REDACTED]. Reference event #101021-4488, the details refer to subjects described as the subjects in this event at the [REDACTED].

address. The details state a woman was screaming, "Don't leave, give me my phone." After throwing the Iphone at [REDACTED], Flores stated that she went to retrieve it. As she picked it up, she stated Griffith ran towards her and pushed her down to the ground. While on the ground, Flores stated that Griffith kicked her, pulled her hair, and had attempted to take the Iphone again.

Flores had bruises on both legs as well as a chunk of her hair, which was located/photographed by Officer J. Rowberry, P#13894. The hair was retrieved in front of the address at [REDACTED] and Flores kept it after it was photographed. Flores stated that after Griffith kicked and pulled her hair, he got up and left in his car. Roux witnessed this, but was unable to be contacted. After Griffith left, Flores followed. Flores stated that Griffith stopped quickly at the light at Torrey Pines northbound at Vegas. Flores stated Griffith exited the vehicle and kicked her driver's side door. No damage was observed. Officers then arrived. Griffith was read Miranda at 0130 hours and responded, "Yes." Griffith stated that he was leaving work and Flores followed him to Roux's residence.

Griffith stated that he got into a verbal altercation with Flores at the residence, but never hit Flores nor took her phone. Griffith stated that he left and finally stopped in front of [REDACTED]. Griffith stated that while he was driving to [REDACTED], Griffith spotted Roux and Roux began following. Flores was also following. Once stopped in front of [REDACTED], Griffith stated that Flores held her Iphone in his face in a taunting manner. Griffith stated he then grabbed her phone and threw it. Griffith stated that he and Flores continued verbally arguing and then all parties left in their respective vehicles. Due to Flores claiming Griffith, her boyfriend of one year, knocked her down, kicked her, and pulled her hair, resulting in bruising and her hair being pulled out, Griffith was charged for battery/domestic violence. Due to Flores stating that Griffith took her phone to prevent her from calling police and throwing the phone additionally to prevent her calling police, Griffith was charged with coercion.
