Contributions to the National Republican Senatorial Committee (NRSC) federal account are limited by law to \$28,500 from an individual and \$15,000 from a PAC in any given year. These contributions are applied against the individual limit per two-year election cycle for contributions to national party committees and federal candidates.

Contributions to the National Republican Senatorial Committee are not deductible as charitable contributions for federal income tax purposes. Contributions from corporations, foreign nationals, and federal government contractors are prohibited. Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation and name of employer for each individual whose contributions exceed \$200 in a calendar year.
